# TOPS's New Focus Taking Shape

In 2016, TOPS will celebrate 20 years of contributions to helicopter tour safety. We're taking advantage of this positive milestone to refresh and refocus TOPS in preparation for an exciting new era for the organization.

While its founders worked on the idea and concept of a way to increase helicopter tour safety, it wasn't until January 1996 that TOPS was officially incorporated. At that time it was an organization of competing helicopter tour operators who recognized collaborating on safety benefited everyone. The program was formed to raise the bar on helicopter tour safety and provide a collaborative environment where the industry's most experienced tour operators could share safety ideas, information and best practices.

In the past 20 years TOPS operators have enjoyed the benefits of increased safety with much lower accident rates than the industry on a whole. Relationships with the FAA and NTSB developed and grew to a point where both agencies collaborate with TOPS on safety rules and recommendations. And membership has steadily grown as the program continues to build and grow organically with the changing helicopter industry.

Today, the TOPS Board of Directors is working on refocusing TOPS from the bottom up – reviewing and strengthening the mission and priorities of TOPS to increase understanding of the value of the program. While we work internally toward a goal of zero accidents, our new marketing efforts simultaneously build public awareness as we move toward a day when tour booking agencies and the general public demand tours only with TOPS operators.

Some of the many new and exciting things you'll see as a part of this effort is a redesigned NewsGram, a new logo, new brochures, a new general newsletter, and a brand new website. # TOPS Fall Meeting Overview and Highlights

### Meeting Overview

The minutes of the 2015 Fall Meeting are located in the Members Only section of the new website, www. topssafety.org.

In addition to the committee reports below, TOPS Audit Committee chair John Becker gave a brief overview of the HAI UAV (unmanned aerial vehicles) committee he's been appointed to and how the industry, including tour operators, should be paying close attention to UAVs, UAV legislation, and ways to embrace the technology.

ARGUS/PRISM gave a demonstration of their online audit product at the request of the board and is working on a demo version for TOPS to consider in order to make the audit process easier for operators and auditors.

The membership also discussed outlining an official procedure regarding suspending members who are out of compliance. The Standardization Committee will review options and present a recommended procedure at the next meeting.

Other discussion topics included capturing institutional knowledge within operators and TOPS. It was recommended an advisory committee be formed of those key people who have contributed to the development and growth of TOPS.

# Committee Updates

#### Standardization

The committee suggested term limits for a committee chair should be determined by the members of each committee. Additionally, the committee is looking into an online software solution for managing audits as well as updating the TOPS mentoring program to simplify the mentorship process for prospective new members. The committee will have a new mentoring process spelled out for the Heli-Expo meeting as well as lead member discussion around doors off operations at the meeting.

#### **Directors of Safety**

The Directors of Safety committee has been working on identifying how TOPS can create a stewardship program to help members develop and expand their SMS programs. The committee will also be working toward realigning TOPS, or at least referencing TOPS items with the pillars and elements of SMS programs, scouring other SMS and accreditation programs for best practices that might be incorporated into the TOPS program, and leverage whatever pressure TOPS can to get Hawaii FAA weather cameras online.

#### **Directors of Maintenance Committee**

The Directors of Maintenance Committee continues to refine the F.O.D. Control Guidelines for inclusion into the program of safety. Additionally, the committee would like to look into duty times for maintenance staff, identifying standards TOPS might be able to incorporate that will work for all members.

#### Audit Committee

The Audit Committee reported all 2015 audits went well and all but one member was recommended for continued membership. The one member that did not meet current TOPS standards, Helicopter Flight Services, is working with the FAA to rectify the issue and TOPS looks forward to welcoming them back once the issue is resolved. In preparation for 2016, be on the lookout for an email from John Becker soliciting recommendations for areas of special interest to be included in the next audit. TOPS Best Practices for 2015 were shared, posted to the website and distributed via email to the membership.

#### Website Committee

The Website Committee unveiled the new website and logo. With this work done, the committee has been renamed the Marketing Committee and will continue their work as they assist in designing a new brochure to support marketing efforts and identify opportunities to better market the organization.

# Congratulations Elling

Our own Elling Halvorson was honored in October during the Museum of Flight's 34th Annual Pathfinder Awards. Every year the Seattle-based museum honors Northwest visionaries that have made significant contributions to the development of the aerospace



industry. Elling received the prestigious Pathfinder Award alongside former Boeing executive and Ford Motor Company CEO Alan Mulally and the late NASA astronaut Michael P. Anderson.

Elling, a resident of Kirkland, Wash., was recognized for his significant contributions to helicopter aviation, tourism and safety. Founder of Grand Canyon Helicopters, a founding member of the Tour Operators Program of Safety (TOPS), a catalyst in the development of quiet helicopter technology, and a former chairman of the Helicopter Association International, Halvorson has significantly shaped today's helicopter industry.
